- Let's understand and value each other's time, therefore irrelevant posts to be avoided, viz., outside health domain, greeting messages, blank emotions, inspirational & devotional messages, social event / personal wishes and invites etc.
- Post messages as a single block rather than a para for each word or sentence to ensure brevity.
- AHMP group is neither a political forum nor a platform for arguing political issues, heated exchanges, fear/rumour mongering, hyped up drama and fake news.
- Do not spam the group with multiple images /videos
- Let the language of communication always be English, If the news is in any other language kindly have the same translated into English.
- It is basic that members maintain a high level of decorum and etiquette in keeping with their own stature and the reputation of the AHMP platform.
- Please don't send multiple "thank you" messages. If you feel gratitude towards someone – tell them in a private message.
- If someone asks a question and you do not know the answer do not respond with "I do not know". Just wait for someone who knows the answer to reply.
- If someone asks a question of a personal nature (like asking for advice) do not respond if someone else has already answered, or else respond to the person directly in a private message.
- Please go through all messages before posting to avoid duplication.
- Do not engage in one-on-one conversations in the group. Kindly switch to private messages to do so.
- Do not post in group between 22:00 hrs IST and 06:00 hrs IST, unless it is an all-out emergency.
- Invite for Conference - Seminar on healthcare to be posted only once for any event, repeat or follow ups, especially Audios / Videos should be strictly avoided in group.
- Discussion on any subject / tag, should be within 7 days from its initial post.
- You can use the platform to showcase some nice work you have done. However, it should be relevant information, however leveraging the site for excessive self-promotion will not be entertained.
- Never EVER use a group to berate someone else or air grievances. If you have an issue address it one on one with the relevant person.
- Members are prohibited from sharing external group invite links in the group. Only admins will do it as and when necessary.
- Do not Change Group Name & Icon: Members are prohibited from changing group name and group icon. Only admins will do it as and when necessary.
- Removal from the Group : Any deviation from the above group will be taken seriously and offenders will be removed from the group without notice.
